

The proposed Minor Amendments involve mill and overlay, pavement rehabilitation with no widening of the existing pavement width proposed. This new project will not have a negative impact on the air quality in the region.

Fiscal constraint will be maintained as the funding for DB# 11343 is being reduced and utilized for DB# 11343A in addition to additional funding currently available in FY 2014.
