

**Public Information Notice**

**SUMMARY**

A Minor Amendment to the FY 2016-2025 Transportation Improvement Program (TIP) has been recommended for Policy Board action by the Technical Advisory Committee per Section A(2) of the latest Memorandum of Understanding between the South Jersey Transportation Planning Organization, New Jersey Department of Transportation and New Jersey Transit Corporation.

**PROPOSAL**

The following Transportation Improvement Program amendment is being recommended for Policy Board approval as follows:

**PROJECT**

***DBNUM X065: Local Congestion Mitigation Air Quality (CMAQ) Initiatives***

At the present time this line item is programmed in the SJTPO FY 2016-2025 TIP in FY 2017 in the amount of \$1,900,000. This action will increase that line item by \$9,273,000 for a total of \$11,173,000.

**BACKGROUND**

CMAQ funds are to be expended on programs or projects that will improve the air quality in the SJTPO region. A total of nine (9) projects were endorsed by the SJTPO Policy Board at its meeting of July 26, 2016. The projects are listed on page two of this notice, some requesting both design and construction funding.

The list also includes projects that were endorsed by the Policy Board at their July 27, 2015 meeting for FY 2016 CMAQ funding that are anticipated to be approved for funding in the upcoming fiscal year. These projects were not able to advance in FY 2016 for various reasons that effected the originally anticipated timeline.

Fiscal constraint will be maintained as the funding for this increase will be provided by NJDOT from unspent CMAQ balances.
