Driveways will be re-graded if adjacent to non-compliant curb ramps, or where a pedestrian access route (PAR) is not provided across the driveway. ROW acquisition may be needed to construct the curb ramps as described. In addition, in order to correct non-compliant grading reconstruction to lessen slopes will extend beyond the existing ROW line to bring project Rt. 30 and Pomona Rd. into compliance with current ADA standards.
